MARTY Sports is a French company specialized in **Manufacturing, Design, Marketing and Installation** of sports equipment and furniture mainly intended for local authorities.

A **100% family-owned company**, it was created in **October 1979** by Raymond and Jeanne Martinez to exploit innovations in the world of athletics, designed by Raymond Martinez, who was a technical executive at the Fédération Française d'Athlétisme.

Their twin sons Laurent and Stéphane took over in 1986 and quickly added their skills in Team Sports and sports hall equipment. Since February 2019 Laurent Martinez has been managing the company.

MARTY Sports Athletics products are **IAAF** certified (International Athletics Federation), **Basketball** recommended by the **FFBB** (French Basketball Federations), **Badminton** classified **FFBAD** (French Badminton Federation).

Football goals are approved by **FIFA** (International Football Federation).



Designing The emergence of European Standards at the end of the 1990s, and also the French decree of June 1996 on the safety of sports equipment (now integrated into the Sports Code), forced **MARTY Sports** to create its own Design Office, which over the years has become a real asset for the company and its customers. The total integration of the design allows us to constantly innovate and support the development of sports, particularly in Athletics, Football, Badminton, Tennis or Basketball, where we work in support of their federations. This also allows us to make a difference from our competitors by offering **MARTY** products. We were also able to integrate eco-design following the completion of our first carbon footprint in 2009



Fabrication

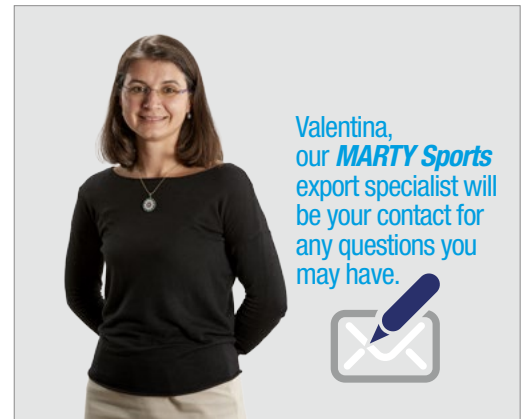
MARTY Sports has been manufacturing since 1981. In order to control quality, we have constantly improved our production resources with modern machines and tools that respect not only working conditions but also the environment, as our factory is located in the countryside. Almost the entire production chain is integrated, from digital cutting of metal or aluminium profiles, manual or automated welding, and finally powder painting on a conveyor.

Commercialization

It is good to design and manufacture, but it is also necessary to commercialize. Since the early 2000s, we have chosen to sell almost everything directly or in very close contact with a network of distributors and installers. MARTY sells MARTY, which allows us to be in direct contact with customers, to be as close as possible to users' expectations and requirements.

For this purpose, our team of technical sales representatives employed by the company is at your disposal with the support of a strong organization administrative staff composed of sales assistants, accountants, a purchasing department and also a shipping department.

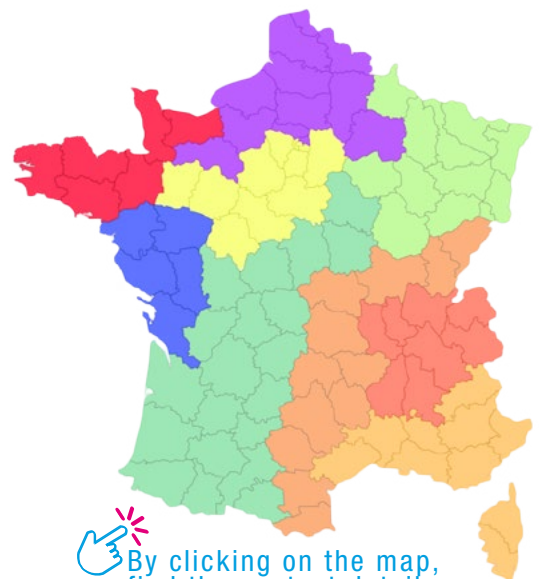
The export is done in relation with national distributors, able to provide the same services as MARTY Sports do in France.

GENERAL CONDITIONS OF SALES

1. OBJECT AND SCOPE OF APPLICATION.

These general terms and conditions of sale apply to all sales of sporting goods and equipment (excluding France) (hereinafter «the Equipment»), concluded between the company MARTY SPORTS, a public limited company with a board of directors and supervisory board with capital of 408,000 euros, whose registered office is Route de la Meignanne, 49370 Saint Clément de la Place registered with the Registry of Commerce and Companies of Angers under number B 317.121.747 (hereinafter «MARTY SPORTS» and professional purchasers (hereinafter «Buyer»).

Any order of Materials implies the acceptance without reserve by the Purchaser of the present general conditions of sale which prevail over any other documents of the Purchaser, and in particular on all general conditions of purchase and this in accordance with article L.441-6 of the commercial register. Any waiver of these general conditions of sale shall be agreed upon in writing between the parties. The special conditions indicated on the quotations and/or the order confirmations addressed by MARTY SPORTS prevail over the present general conditions of sale. Any other document than these general conditions of sale, and in particular the catalogs, pictures, prospectuses, advertisements, notices, have only an informative, indicative and non-contractual value. The material sold may be modified in relation to the texts, descriptions or engravings and prints of the MARTY SPORTS catalogs, without warning in order to take account of the evolutions of the applicable professional and public regulations and this without the Purchaser may consider that the amendments constitute a change of the contract of sale.

2. ORDERS.

The sales are perfect only after the express and written acceptance of the order of the Buyer which will be materialized by an order confirmation issued by MARTY SPORTS. Orders issued by the Buyer are firm and not cancellable unless exceptional and written agreement of MARTY SPORTS. MARTY SPORTS reserves the right to refuse any order issued by a Buyer who has not made the agreed payment and/or with which MARTY SPORTS would have had a dispute of payment in the context of an order and/or any order mentioning a price of equipment not corresponding to the tariff in force on the date of issue of the order and/or any order which would indicate an abnormally long delivery time or a duration of more than 3 months.

3. DELIVERY AND MATERIALS RECEPTION.

3.1 Delivery time and delivery conditions.

MARTY SPORTS will make its best efforts to execute the orders and respect the delivery times it indicates when it accepts the order except in case of force majeure within the meaning of article 1148 of the Civil Code or events such as strikes, lock-out, epidemics, war, requisitioning of fire, flood, interruption or delay in transport or any other cause causing total or partial unemployment of MARTY SPORTS. The delivery times indicated in the quotation and/or acceptance of the order do not constitute a delay of rigor. Accordingly, unless otherwise agreed in writing between MARTY SPORTS and the Purchaser, any delays of delivery shall not give rise to any penalty or indemnity, nor to justify the cancellation or termination of the order. If partial deliveries are requested by the Purchaser, these will be made subject to the prior agreement of the latter concerning the payment of additional transport costs. In case of non-payment of an invoice that has expired, MARTY SPORTS reserves the right to suspend any delivery in progress and/or to come.

3.2 Materials reception.

The Materials delivered comply with the applicable regulation and with the technical standards expressly stated in the quotation. The Buyer shall have five (5) working days from the delivery of the Materials to proceed with the receipt of the Materials and issue, if necessary, by registered letter with acknowledgment of receipt, any reserves to MARTY SPORTS. It shall be the responsibility of the Purchaser to provide all justifications as to the actual defects or deficiencies found. No claim can be accepted in case of non-compliance by the Buyer of these formalities. By explicit agreement, any installation of the Material by the Purchaser shall be without reserve receipt of the Materials. No returns of Materials will be made by the Buyer without the prior express written consent of MARTY SPORTS, obtained in particular by fax or e-mail. The Materials will have to be returned over in the state with their original packaging and have not been used. The costs of return will be borne by MARTY SPORTS by MARTY SPORTS in the case that an apparent defect, or missing, has actually been ascertained by the latter or by its agent. MARTY SPORTS will replace or repair, at its option, within a reasonable time and at its own expense, the non-conforming materials without the Buyer being entitled to any compensation, penalties, damages, or resolution of the order. The claim made by the Buyer under the terms and conditions described in this article shall not suspend payment by the Purchaser of the Materials concerned.

4. TRANSFER OF OWNERSHIP AND RISKS.

In the case of non-payment by the Buyer of all or part of the price of the order, MARTY SPORTS reserves, until the complete payment of the price, in principal and accessories, a right of ownership on the Materials in accordance with article L.624-16 of the French Commercial Code. On the other hand, the transfer of the risk of loss and deterioration of MARTY SPORTS Materials will be realized as soon as the Materials are delivered to the Buyer according to the conditions indicated in article 3.1 hereof. It is the responsibility of the Purchaser to subscribe for the necessary insurance.

5. TARIFF - PRICE.

The MARTY SPORTS tariff applies to all Buyers on the same date and for the duration indicated in the latter. This can be reviewed during the year. Any tariff changes shall be the subject of an information to customers and will be applicable for any order issued as of the date shown of the new tariff. Unless otherwise specified in the quotation, prices are quoted INCOTERMS EXWORKS, excluding tax and customs duties, including packing.

6. PAYMENT CONDITIONS.

Payment terms are:

- For all new Buyers, the payment of the price must be made in totality when placing the order of the Materials.
- For registered customers, unless written agreement between the parties, the payment of the price must be made in totality when placing the order of the Materials. However, if a delay in payment had been previously noted, the payment of the orders should take place in totality when the order is placed.

Payment methods:

- For all Buyers the payment will be made by bank transfer.

Advance payments are made without any discount.

Any delay in payment at maturity will result in penalties equal to 5 times the legal interest rate in effect in France on the due date. These penalties will automatically be paid to MARTY SPORTS without prior formal notice and without prejudice to any other action which MARTY SPORTS may be entitled to institute against the Buyer in this respect. In case of non-compliance with the payment terms set out above, MARTY SPORTS also reserves the right to suspend or cancel the delivery of outstanding orders, to suspend performance of its obligations. Moreover, in case of intervention by our litigation company, the Buyer will also be liable for an indemnity equal to 15% of the unpaid amount of the order, and without prejudice to any other action that MARTY SPORTS shall be entitled to sue the Buyer as such.

7. COMMERCIAL GUARANTEE.

In addition to the legal warranty of latent defects, the Materials delivered by MARTY SPORTS benefit from a warranty of twelve (12) months under normal conditions of use, from delivery as defined in Article 3.1 of these General Sales Conditions against any manufacturing defects rendering them unfit for the purpose of the activity for which they are intended. In order to assert its rights, the Buyer shall, on pain of forfeiture of his rights under this warranty, inform MARTY SPORTS, in writing within the twelve-month period specified above, of the existence of the defect. Under this warranty, MARTY SPORTS undertakes to repair or replace within a reasonable period of time the Equipment which for the defects will satisfy the conditions under which it will benefit from this commercial guarantee, excluding of any other costs, damages and interest and/or indemnities of any kind whatsoever such as, without limitation, penalties, traveling and/or subsistence expenses and/or cost of assembly or disassembly of the Materials. Implementation of the warranty will not extend the warranty period for the replaced or repaired equipment. Any warranty is excluded in the case of misuse or use of the equipment contrary to the instructions for use and/or for the use for which the equipment is intended, negligence or lack of maintenance, lack of surveillance from the Buyer of third party, normal use of the Material or force majeure, of reparation and/or modification by the purchaser or a third party, improper installation, false maneuver, deterioration, sabotage, from any accident or damage likely to damage the equipment, such as but not limited to damages caused by weather, water, equipment or devices not supplied by MARTY SPORTS.

8. LIABILITY.

MARTY SPORTS liability for all causes, with the exception of personal injury and gross negligence, shall not exceed the duty-free price of the material and only covers direct material damage caused to the Buyer, who remains alone responsible for any damage caused to third parties, which would result from fault exclusively attributable to MARTY SPORTS in the execution of the order. Under no circumstances will MARTY SPORTS be liable to compensate for any intangible and/or indirect damages such as operating losses, profit, luck, commercial loss or loss of profit. The purchaser warrants the waiver of recourse by its insurers against MARTY SPORTS beyond the limits and exclusions set out above.

9. INTELLECTUAL PROPERTY.

The drawings and pictures, sketches and designs of the catalog as well as the technical documents given to the buyers are the exclusive property of MARTY SPORTS and can not be reproduced, disseminated or used in any way without its express, written and prior authorization.

10. PARTIAL INVALIDITY.

In the case that one of the provisions of these general terms and conditions is held to be invalid or contrary to a provision of public order by a competent court, these general conditions will continue to effects for all other provisions provided that the nullity pronounced does not affect all the contractual stipulations.

11. NON-WAIVER.

Any failure or renunciation by MARTY SPORTS to avail itself of the performance of one of the obligations can not be interpreted as the will of MARTY SPORTS to renounce subsequently the execution of the said obligations.

12. DISPUTE – ATTRIBUTION OF JURISDICTION.

IN THE ABSENCE OF AGREEMENT, ANY DISPUTE RELATING TO THE CONCLUSION, INTERPRETATION, PERFORMANCE OF THE PRESENT GENERAL CONDITIONS AND ORDERS WILL BE SUBMITTED TO THE COMMERCIAL OF ANGERS EXCLUSIVELY COMPETENT, INCLUDING REFERRED, NOTWITHSTANDING THE GUARANTEE CALL OR THE PLURALITY OF DEFENDERS.

13. APPLICABLE LAW.

By express agreement between the parties, this contract is governed and subject to French law. The application of the Vienna Convention of 11 April 1980 is excluded. For convenience, an English translation has been established. However, in case of dispute, only the French text shall prevail.

FOR THE SALES WITH INSTALLATION OF THE MATERIALS BY MARTY SPORTS

14. The installation of material by Marty Sports must be considered as a complementary service to the sale and consequently can not have the effect of modifying the legal nature of the contractual relationship, the order remaining governed by the law applicable to the sale and by the present general conditions of sale. This qualification will be imposed to the judges in case of dispute over the present general conditions of sale.

15. In addition, MARTY SPORTS is not subject to the obligation to join a bad weather of paid vacation fund, to provide individual basic insurance and/or participate in the pro-rata account, the latter being obligations specific to the activity Building not belonging to MARTY SPORTS.

16. Limits of the work of the batch SPORTS EQUIPMENT.

These benefit limits are specified and are those specified in the AFNOR 52-400 standard.
